### What are **your** benefits?

### How to make your **booking** and **general terms and conditions**:

- Booking requests are to be made online on the website of the participating partner (please see domain above).
- Shareholders only qualify for the travel benefits, if reservations are made directly with our participating partners. No travel benefits allowed if booking is made via a tour operator, travel agent and/or online booking platform.
- Bookings are subject to availability.
- Rates as published by our participating partners shall apply.
- Travel benefits can only be granted if your shareholder number is provided with the booking request. The validity of the shareholder number will be verified and proof of identification may be required.

- Your travel benefits as a shareholder are linked to you personally and do not apply to your relatives and friends. Each traveler needs to have his/her own shareholder number to qualify for the travel benefits.
- Bookings for several shareholders can only be accepted if valid shareholder numbers are submitted for all travelers.
- No discounts will be granted on any bookings prior to the issue of the shareholder number.
- The benefits do not add up for shareholders with more than one share in their name (e.g. 1 share = 20% discount; 2 shares ≠ 40%).
- Should a company / legal entity / travel agent et.al. become a shareholder, a natural person must be named who will be eligible for the benefits
- Meals and extras / activities (excluding Rhino Tracking) are to be paid at the normal rate.
